# **Vision Recycling**

Vision Recycling transforms yard trimmings, wood debris and food waste into Compost, Mulch, Soil Amendments, and Decorative Bark.

Vision Recycling emerged in 1993 from a substantial local landscape company, Del Conte's Landscaping Inc. The founder of both companies, Tom Del Conte, has 40 year's experience as a landscape contractor and 20 years in the organics, composting and recycling industry. Tom was instrumental in the development of the Green Business requirements for landscapers. He sat on the County Green Business Advisory Council and has given talks to Bay Friendly Certification classes.

In the early 90's Vision Recycling acquired equipment to convert the green waste generated by the landscape firm's maintenance division into organic amendments used by the landscape construction division. Soon thereafter, Vision secured a

contract with the County of Santa Cruz to process their organic material. The company also has a long term contract with the Salinas Valley Solid Waste Authority.

Vision Recycling comes from the horticulture side of the waste stream as opposed to the garbage side, utilizing sustainable solutions for its processing. Vision's staff sees the importance of transforming green waste into valuable resources that the local community can use.

In 1996 Mr. Del Conte took on a partner, Roberto Aguirre, who has mastered the skill sets required to maximize productivity and safety. The company currently operates 6 facilities on a turn-key service basis and provides mobile services to many other landfill operations in all parts of Northern California. Through these operations, Vision now processes over 200,000 tons of feedstock per year.

Vision Recycling endeavors to partner with local agencies who wish to have a top quality organics recycling operation within their own community. The Vision Recycling model supports local commerce, reduces

trucking emissions and traffic, promotes buying local, creates community pride for using home grown organics on a large scale, and ultimately reduces product price from both ends of the recycling circle.

In 2013 Vision began a new paradigm by opening two facilities in Newark and Livermore on Vision Recycling's own property. These stores are the beginning of many more to come.

Vision Recycling maintains a solid business platform with innovative visions!

# That Means I Can't Sue My Employer

I was walking around a landscaping conference the other day, and my cell phone rang. Not unusual, since I get several phone calls from unfamiliar telephone numbers connecting me with various business owners looking for an answer to a pressing human resources question, every day. However, this call was very different to say the least.

An employee from a California-based company found my telephone number and sought my advice on a payroll practice. By way of background, as most rational people would attest, California has numerous wage and hour laws that easily exceed the definition of being burdensome. One such set of wage and hour laws addresses pay stubs: The document that accompanies a paycheck given to an employee. California law stipulates that 10 pieces of very precise information must be found on every pay stub, lest the employer be confronted with severe financial penalties. Beyond that requirement, California law requires that every employee receive a pay stub from their employer each pay day. That point was the premise for the employee phone call.

The employee told me that his employer provides all company employees with an electronic pay stub each pay day. But he wanted to know if that electronic document satisfied all legal requirements in the same manner that a paper document would meet the standard. In response to his question, I simply said "yes."

Incredulously, he pursued further by

stating, "Are you telling me that both the electronic and the paper pay stubs satisfy California law?." Again, I repeated "yes." After some interesting combinations of profanity, the employee said: "But that means I can't sue my employer!" To which I remarked, "So you are upset that your employer is treating you fairly, in compliance with state law?" As you would gather, he then responded, "You don't understand, that means I can't sue my employer." I ended the conversation immediately thereafter.

It's difficult for business owners to not be paranoid.

Aside from the specific issue in this phone call, business owners must always be prepared, compliant, and clairvoyant, especially when involving wage and hour issues. For example, employers must:

- Become fluent with all relevant local, state, and federal wage and hour laws,
- Train managers and supervisors on the proper administration of those laws,
- •Hold managers, supervisors, payroll staff, etc. accountable for ensuring legal compliance.
- Conduct regularly-scheduled (e.g., monthly, quarterly, annually) wage and hour audits,
- Purchase the wage and hour add-on coverage, as part of your company's EPLI policy, and
- Remember there is "personal" liability for many local, state, and or federal wage and hour violations.

# **EBMUD Upcoming Webinars**

#### Native Plant Design and Maintenance Webinar Monday December 14, 2020 2pm-3:15pm

As a follow up to the October 5, 2020 presentation on "Ecoregional Approach to Native Plant Selection," Jennifer de Graaf will present on designing and maintaining native plant gardens. Jennifer will use a number of CA native plants such as Bouteloua gracilis 'Blond ambition', Yarrow, Salvia x. clevelandii, Quercus agrifolia, Carex tumulicola, and Blechnum spicant, etc. to demonstrate important workflow considerations to design native plant gardens and to reduce hazards in the event of a wildfire. This critical thinking method can be applied to a variety of garden settings.

Jennifer has 22 years of professional landscape design and project management experience of parks, schools, hospitals, trail systems, streetscapes, historic properties, commercial housing, and estates and private residences. For five years, Jennifer taught courses for UC Berkeley Extension in the Landscape Architecture Certification Program. She also served as the Lead Trainer and Director of Education for ReScape CA.

Jennifer is licensed as a Landscape Architect in California, a LEED Accredited Professional, ReScape CA Qualified Professional, ReScape CA Rater, and a Qualified Water Efficient Landscaper. Jennifer received her Bachelor's in Landscape Architecture from Oklahoma State University.

EBMUD Water Conservation Division staff will also provide an update on EBMUD water supply, water demand, and water conservation programs.


